Breaking an Ancestral Sale to an Ungodly Entity

(2-19-22)

Apparently an ancestral transaction of a sale of future generations to a specific entity or project is different enough from an ancestral bargain or barter or sale of a birthright to not be covered by those renunciations. This renunciation will endeavor to cover such sales.

The ancestor making the sale often gains some spiritual advantage from doing so. Possibly this includes the ability to live on in the spiritual realm after physical death (Isa. 28:15), but it seems that he can only do this as long as he can be connected to a living descendant and a cosmic being. The connection of the three entities forms a triad that is most likely established as part of the sale agreement. Sometimes a fourth entity is involved, creating a quadriad. If the triad or quadriad is broken, the ancestral spirit will expire, and the survivor will be freed from his influence in his/her life.

You can do the “Breaking an Ancestral Bargain/Barter” and “Restoring a Stolen or Sold Birthright” in a generic way to cover your possible bases. However, I advise you to wait until you know if you have been sold to a specific entity or project before doing this renunciation as I believe that it needs to be done with the specific name of the entity or project involved.

Preliminary Instructions:

1. Pray the “Binding and Separating Prayer.”
2. Ask the Ancient of Days to issue restraining orders against all evil beings, ungodly entities, and unseen human agents wanting to interfere in any way with the person successfully being able to do the renunciation.
3. Ask Jesus, as the person’s Advocate, to step before the Father’s throne to intercede on his/her behalf and allow the correct primary identity to be unhindered in being able to express his/her own free will through the complete renunciation.
4. Get the person’s agreement to the overall purpose of the renunciation. This gives you a basis to appeal to God on behalf of the person if the person gets blocked from being able to speak at any time.
 - a. You can do this by asking:

Do you desire to ask the Ancient of Days to nullify any ancestral sale of yourself to _____ (name the specific entity or project)?

- b. If the person does reach a point at which he or she is not able to speak or has been switched out of the presenting position, you can appeal to God in the following manner:

Ancient of Days, I appeal to You that _____ has already spoken his/her will that he/she desires for You to nullify any ancestral sale of him/herself to _____ (name the specific entity or project).

I ask You to take authority over all fallen sons of God and their derivatives and all ancestral spirits and cancel their assignments and abilities to interfere in this process in any way.

I ask, Lord Jesus Christ, for You to step before the Father’s throne as _____’s Advocate and to intercede on his/her behalf to allow him/her to be able to return to a position to finish this renunciation.

As you wait for this to happen, continue to give praise and honor and worship to the Most High God.

This renunciation is presented in two formats:

1. The first is a prayer that can be prayed by the person.
2. If this is not easy for the person to do, you may use the second format below it, which allows the facilitator to ask the person yes or no questions in order to get the necessary statements of the person's free will ("the word of their testimony," according to Revelation 12:11), after which the facilitator can pray on behalf of the person.

Prayer Format

I. Breaking the generational inheritance

Ancient of Days, as Judge of all the earth, I come before You, in the name of the Lord Jesus Christ, my Savior and Advocate, to stand in the gap on behalf of my ancestral lines on my mother's and my father's sides (both biological and custodial—if different) to acknowledge, renounce, and confess on their behalf the iniquities of:

- Rebellion against God
- Selling one's future generations to ungodly entities or projects in exchange for spiritual power, the ability to live on in the spiritual realm after physical death, or any other ungodly purpose
- Making covenants with death
- Disrespecting human life and God's destiny for the children He created
- Serving Lucifer's agenda rather than God's
- Worshipping and sacrificing to Lucifer and _____ (name the spiritual entity involved)
- Offering child sacrifices

I declare before You that I forgive my ancestors for their actions that brought these generational inheritances and their consequences into my life. I relinquish all hate and desires for revenge into Your hands for You to bring judgment against them.

I also renounce and repent of any and every way that any part of me has knowingly or unknowingly, willingly or unwillingly, participated in these iniquities myself. (Be specific about the various ways which God brings to mind that you have done this.)

I ask You, in the name of the Lord Jesus Christ, to put His shed blood between me and these grievous generational iniquities, breaking these inheritances and their curses from my life and from the lives of my descendants going forward forever.

I ask You to remove, or disconnect from us, all evil and ungodly entities; human spirits of whatever status; usurped powers, forces, energies, lights, life forces, mists, winds, slimes; holograms; manipulated life forms; and anything else that gained access to us because of these generational inheritances and their curses, to pass judgment on them, to dispatch them to the destinations of Your choosing, as appropriate, and to close and seal with the blood of the Lord Jesus Christ all portals and orifices they used for access to us. Please fill all evacuated places with Your true Holy Spirit.

As You remove these generational curses from my life and my descendants, will You please release any of Your generational blessings intended for us that were blocked because of these curses?

Thank you, Ancient of Days.

II. Breaking the ancestral sale

Ancient of Days, in the name of the Lord Jesus Christ, I also declare before You that I reject any sale that any of my ancestors, including any of my biological or custodial parents, grandparents, relatives, or step-relatives, made of myself, to _____ (use the name of the entity that you know or think might be true) or any other evil spiritual or ungodly entity for lifelong ownership and service and/or to be used in _____ (name the specific project or role to which you were sold into) in exchange for some spiritual benefit for themselves, including being allowed to live on in the spiritual realm after death, being able to be connected to me or to live through me, or to use me as an anchor point for ungodly activities. I ask You to nullify any such sale completely and forever with the blood of the Lord Jesus Christ as well as any sacrifices and/or mixing or drinking of blood that empowered them. If I have the authority to do so, I also ask You to cancel the benefits that were gained by my ancestors or other relatives in making this sale. I declare to You that I desire to belong to You, My Creator, alone.

Please remove or disconnect from me _____ (the entity to whom you were sold) along with all of his cohorts and underlings and all other evil, ungodly, and human spirits of whatever status; usurped powers, forces, energies, lights, life forces, mists, winds, slimes; manipulated molecular structures and life forms; robotic, electronic, and mechanical creatures; and anything else that gained access to me and my descendants because of this sale. Please also disconnect me from all evil spiritual or ungodly lines, grids, planes, networks, and satellite systems that I was connected to as a result of this sale and my connection to _____ (name the entity and/or project). I ask You in your mercy and grace to remove from me all effects and further developments that this sale had in my life and in my descendants' lives.

If the sale resulted in me being connected into one or more triads or quadriads with Lucifer, the Dragon, the Beast, the False Prophet, _____ (name the entity to which you were sold) or any other evil cosmic being or ungodly entity and the spirit of the ancestor making the transaction, I ask in the name of the Lord Jesus Christ that You would completely sever them and release me from all connection to the other beings and the entire hierarchy of evil and ungodly beings connected to them.

If any dissociated part of me or of my created-by-You life force was taken into captivity in any place away from me, including in Satan's counterfeit realms of darkness, light, and all the colors of the rainbow, the black hole, the Catacombs of Death, the Alternate Universe, or another dimension, realm, or void between them in a life-for-life or death-for-death exchange; to serve as an anchor for any project, structure, or entity or for any other reason because of the sale, will You please return them to me safely, cleansed by the blood of Jesus Christ of all entities, attachments, programming, inserts, connections, and contamination of any kind? If they were involved in any triad or quadriad connections, please sever them and disconnect my parts from the other entities involved as well as from their cohorts and underlings. When they are safely returned from these places, I ask You to disconnect me from all spiritual conduits connecting me to the places where they were, close them off, and seal them with the blood of the Lord Jesus Christ.

I declare that I reject on their behalf all allegiance to the counterfeit sun, moon, morning star, and other spiritual authorities ruling over the places where they were, and I ask You to disconnect me from them and the entire hierarchy of evil spiritual and ungodly entities connected to them.

I also ask You to break all ungodly relationship bonds between me and:

- The people and entities involved in making the sale;
- _____ (the entity to whom the sale was made);
- Any counterfeit trinity of which this entity is a part (name the specific entities involved in the trinity if you know them)
- All other participants in the ceremony, including the witnesses and whoever officiated;
- All sacrifices made to empower the transaction;

- All people and animals that provided blood for any blood covenant;
- All members of any triad or quadriad that was formed with me or any of my parts;
- All spiritual authorities over any dimension or realm where any part of me was taken or where the sale was made;
- All people and entities with whom these people and entities were or are in ungodly relationship bonds.

Please remove, or disconnect me from, all evil spiritual beings; ungodly entities; human spirits of whatever status; usurped powers, forces, energies, lights, life forces, winds, mists, slimes; manipulated molecular structures or life forms; robotic, electronic, or mechanical creatures; or anything else that gained access to me through these ungodly bonds. Also remove from me any part of their souls, spirits, or life forces that intermingled with mine and return to me, cleansed by the blood of Jesus Christ, any part of my soul, spirit, or life force that intermingled with theirs. When these exchanges are complete, please sever the spiritual conduits between us, close them, and seal them with the blood of the Lord Jesus Christ.

I ask that You pass judgment on _____ (name the entity to which you were sold) and all evil spiritual beings and ungodly entities removed from me, dispatch them to the destinations of Your choosing, as appropriate, fill the evacuated places in me with Your true Holy Spirit, and close and seal the portals and orifices they used for access with the blood of the Lord Jesus Christ;

Please remove all manipulated molecular structures and life forms in all of their multi-dimensional and transmutable representations along with all mirror and holographic images; reflections; shadows; back-up generations; and self-replicating mechanisms.

I also ask You, Ancient of Days, to nullify completely and forever with the blood of the Lord Jesus Christ any curses set to be released if I should nullify this sale, including any requiring my death.

Please apply everything that I have requested to my generational line going forward.

Please cleanse with the blood of the Lord Jesus Christ and His living water every part of my spirit, soul, and body down to a cellular and intracellular level, including my DNA, RNA, mitochondria, epigenetic markers, and the very image in which You made me; of all effects of the spiritual bondages from which You have set me free today.

Lord Jesus Christ, as my true Advocate before the Father, please correct anything that I have said inaccurately or incompletely and cover anything that I have missed in order to free me completely from any sale that any of my ancestors, including any of my biological or custodial parents, grandparents, relatives, or step-relatives, made of future generations, including myself, to _____ (use the name of the entity that you know or think might be true) or any other evil spiritual or ungodly entity for lifelong ownership and service and/or to be used in _____ (name the specific project or role to which you were sold into) in exchange for some spiritual benefit for themselves, including being allowed to live on in the spiritual realm after death, being able to be connected to me or to live through me, or to use me as an anchor point for ungodly activities.

Finally, Ancient of Days, I ask You to seal the work that was done, cancel all back-up plans, and declare that no retribution or retaliation whatsoever is permitted. Also cleanse all of us who are present with the blood of the Lord Jesus Christ from any contamination we have received from interacting with the evil realm today.

I thank You for Your power, love, grace, and mercy that has redeemed me from this major bondage today.

I pray all of this in the name of the Lord Jesus Christ.

Facilitator-Led Format

 - Disrespecting human life and God's destiny for the children He created;
 - Serving Lucifer's agenda rather than God's;
 - Worshipping and sacrificing to Lucifer and _____ (name the spiritual entity involved)
 - Offering child sacrifices?
2. Do you choose to forgive your ancestors for their actions that brought these generational inheritances and their consequences into your life, relinquishing all hate and desires for revenge into God's hands for Him to bring judgment against them?
3. Do you renounce and repent of any and every way that any part of you has knowingly or unknowingly, willingly or unwillingly, participated in these iniquities yourself? (Be specific if God brings anything to mind.)

B. Pray:

Ancient of Days, as Judge of all the earth, I come before You in the name of the Lord Jesus Christ and ask You on the basis of what _____ has stated to put the blood of the Lord Jesus Christ between him/her and these grievous generational iniquities and to break these generational inheritances and their curses from his/her life and from the lives of his/her descendants going forward for a thousand generations.

I ask You to remove from _____ and his/her descendants all evil and ungodly entities; human spirits of whatever status; usurped powers, forces, energies, lights, life forces, mists, winds, slimes; holograms, manipulated life forms; and anything else that gained access to them because of these generational inheritances, to pass judgment on them, to dispatch them to the destination of Your choosing as appropriate, to close and seal with the blood of the Lord Jesus Christ all portals and orifices they used for access to them, and to fill all evacuated places with Your true Holy Spirit.

As You remove these generational curses from _____'s life and his/her descendants, will You please release any of Your generational blessings intended for them that were blocked because of these curses?

Thank you, Ancient of Days.

I pray this all in the name of my Lord Jesus Christ. Amen.

Do you declare before the Ancient of Days that you reject any sale transaction that any of your ancestors, including any of your biological or custodial parents, grandparents, relatives, or step-relatives, made of future generations, including yourself, to _____ (use the name of the entity that you know or think might be true) or to any other evil spiritual or ungodly entity for lifelong ownership and service and/or to be used for _____ (name the specific project or role to which you believe the person may have been sold into) in exchange for some spiritual benefit for themselves, including being allowed to live on in the spiritual realm after death, being able to be connected to you or to live through you, or to use you as an anchor point for ungodly activities?
2. Do you desire the Ancient of Days to nullify that sale transaction completely and forever, as well as all sacrifices and/or mixing or drinking of blood that empowered them, with the shed blood of the Lord Jesus Christ?
3. Do you desire Him to cancel the benefits gained by the ancestor or other individual if you have the authority to do so?
4. Do you desire to express your desire to be owned only by the Most High God, your Creator?
5. Do you desire the Ancient of Days to remove, or completely disconnect you from, _____ (name the entity to which he/she was sold) along with all of his cohorts and underlings and everything else that gained access to you, or you were connected to, because of this sale; including all evil spiritual beings, ungodly entities, and human spirits of whatever status; all manipulated molecular structures and life forms; robotic, electronic, and mechanical creatures; all usurped powers, forces, energies, lights, life forces, winds, mists, and slimes; and all evil spiritual or ungodly lines, grids, planes, networks, and satellite systems?

7. Disconnect _____ from all spiritual conduits connecting him/her to those dimensions and realms when his/her parts are safely returned from them, close the openings, and seal them with the blood of the Lord Jesus Christ;
8. Disconnect _____ from the counterfeit sun, moon, morning star, and other spiritual authorities ruling over these places along with the entire hierarchy of spiritual and ungodly entities connected to them;
9. Break all ungodly relationship bonds between _____ and:
 - The people and entities involved in making the sale;
 - _____ (the entity to whom the sale was made);
 - Any counterfeit trinity of which this entity is a part (name the specific entities involved in the trinity if you know them);
 - All other participants in the ceremony, including the witnesses and whoever officiated;
 - All sacrifices made to empower the transaction;
 - All people and animals that provided blood for any blood covenant;
 - All members of any triad or quadriad that was formed with _____ (the person for whom you are praying) or any of his/her parts;
 - All spiritual authorities over any dimension or realm where any part of him/her was taken or where the sale was made;

Pass judgment on _____ (the entity to whom he/she was sold) and all evil spiritual beings and ungodly entities removed from _____, dispatch them to the destinations of Your choosing as appropriate, fill the evacuated places with Your true Holy Spirit, and close and seal the portals and orifices they used for access with the blood of the Lord Jesus Christ;
13. Please remove all manipulated molecular structures and life forms in all of their multi-dimensional and transmutable representations along with all mirror and holographic images; reflections; shadows; back-up generations; and self-replicating mechanisms.
14. Please cleanse with the blood of the Lord Jesus Christ and His living water every part of _____'s spirit, soul, and body down to a cellular and intracellular level, including his/her DNA, RNA, mitochondria, epigenetic markers, and the very image in which You made him/her; of all effects of this sale.
15. Nullify completely and forever with the blood of the Lord Jesus Christ any curses set to be released if _____ should break this ancestral sale, including any requiring his/her death;
16. Apply everything he/she has renounced and requested to his/her entire generational line going forward.

C. Closing prayer

Lord Jesus Christ, as _____'s true Advocate, please step in and correct anything we have said inaccurately or incompletely and cover anything we have missed in order to free him/her completely from any sale transaction that any of his/her ancestors, including any of his/her biological or custodial parents, grandparents, relatives, or step-relatives, made of _____ to _____ (use the name of the entity that you know or think might be true) or any other evil spiritual or ungodly entity for lifelong ownership and service and/or to be used in _____ (name the specific project or role to which he/she was sold into) in exchange for some spiritual benefit for themselves, including being allowed to live on in the spiritual realm after death, being able to be connected to _____ (the person for whom you are praying) or to live through him/her or to use him/her as an anchor point for ungodly activities.

Ancient of Days, please seal the work that You have done, cancel all back-up plans, and declare from Your heavenly throne that no retaliation or retribution whatsoever is allowed.

Also cleanse all of us present with the blood of the Lord Jesus Christ from all contamination we may have received from interacting with the evil realm today.

We thank You for Your power, love, grace, and mercy that has set _____ free from this major bondage today.

We pray all of this in the name of the Lord Jesus Christ.
